

Lexington LWV Annual Meeting April 18



March 20 Naturalization Ceremony and Voter Registration



The Grace Notes, Transylvania University women's acapella group, provided patriotic music for the 168 citizenship applicants and their family and friends at the recent naturalization ceremony.

On Friday, March 20, 168 applicants from 61 countries received their certificates of citizenship at Haggin Auditorium on the Transylvania University campus. The ceremony was presided over by the Honorable Karen K. Caldwell, Chief U.S. District Judge and 1977 Transylvania graduate.

Afterwards the new citizens had the opportunity to register to vote. They were assisted by LWV members Nancy Chesser, Carolyn Holmes, and Judy Johnson along

with representatives from the Kentucky Secretary of State's office. Because of courthouse renovation, there will be no more naturalization ceremonies in that location for the next two years. During this time, ceremonies other than the yearly Transylvania ceremony will be held in Frankfort.



Lexington LWV Book Club Past and Future...

The LWV Book Club met on Tuesday, March 17, at 1:30 p.m. Cindy Heine led a discussion of the book by Jeffrey D. Clements, *Corporations Are Not People: Reclaiming Democracy From Big Money and Global Corporations*. The subject of this book, corporate "personhood" certainly engaged the readers! For those who could not join the discussion, we recommend reading the book on your own. It is clear and comprehensible and sheds some light on the "dark money" unleashed by the *Citizens United* decision of the Roberts court.

The next book to be discussed is *The Empire of Necessity: Slavery, Freedom and Deception in the New World* written by Greg Grandin. Historian Grandin tells the true story of a slave insurrection aboard a ship named the Tryal in 1805 in which the West African men and women rose up and seized the ship. He uses this story to approach the broader topic of the transnational slave trade's impact on the whole world causing economic, social and political upheaval that still reverberates today.

The book club will feature the book at their meeting on Tuesday, April 21, at 1:30 p.m. The location is Terry Naydan's house, 3013 Charleston Boulevard. Chris Seiber will lead the conversation. Efforts to Address Homelessness in Lexington Explained

Charles Lanter joined League members at Joseph-Beth for "Dinner and Democracy" on Monday, March 23. As director of the newly commissioned LFUCG office to deal with the issues surrounding homelessness, Mr. Lanter shared information and answered questions, helping us understand the complexities of the topic.

We learned of the data collecting going on through a collaboration between UK and the Hope Center that will be used to better under-

stand the problem. He explained the mental health court diversion program to address needs of transients and support their progress to independence. He also described the resources of various shelters in the community from the Salvation Army (for women and children) to Arbor Place (for children) and the Hope Center (for men).

Mr. Lanter invited members to attend the meetings of the Homelessnes Prevention and Intervention Board in order to stay informed. The next scheduled meeting will be September 9 at 1:30 p.m. Check out the page for his office on **lexingtonky.gov**. A Lesson in Good Citizenship

In the legislative session which just ended there was a devious attempt to loosen already lenient campaign rules. **HB 203** relating to operations of the election registry was amended by a Senate committee to increase the amount of campaign contributions allowed, and to change filing procedures. <u>It was never presented to the public</u>. <u>There were no hearings</u>. The LWV learned about it only because a member happened to be in the Capitol toward the end of the session.

After the LWV and Common Cause put out Action Alerts to members there was an outpouring of citizen response. Rep. Jim Wayne noted in his remarks to the House there had been a public outcry about the lack of transparency in the process to pass this piece of legislation. He referred to "the few guardians of open government who have quickly learned about what has been done behind their backs: Common Cause and the League of Women Voters."

When the bill was called for a vote in the House it was defeated 43-49. As Pat Murrell, president of the Louisville LWV, pointed out—individuals **CAN** make a difference! Let us keep this example in mind as we look forward to the 2016 legislative session.

Christian Muslim Dialogue


