



The Lexington League of Women Voters will welcome Lexington Vice Mayor Steve Kay as guest speaker at the annual meeting, Saturday, April 16.

The vice mayor also chairs the Design Excellence Task Force, cochairs the Infill and Redevelopment Steering Committee, and participates in the Metropolitan Planning Organization, Corridors Commission and UK President's Sustainability Advisory Committee. Within the urban county government he serves on the Environmental Quality and Public Works Committee, the Budget, Finance and Economic Development Committee and Planning and Public Safety Committee. All of his various responsibilities prepare him to be an eloquent speaker to share progress toward meeting the

# Status of Legislation

The general assembly is winding up business with much attention focused on multiple versions of a state budget. March 28 and 29 are Concurrence Days followed by a ten day veto recess. Legislators will return to business on April 11 and Sine Die adjournment follows on April 12. However, the General Assembly has the flexibility to shuffle its final working days through April 15 and legislators are hopeful work on more legislation will be completed before the final working day.

- Thank legislators for passing HB 59 (victim protection) and SB 63 (unprocessed rape kits), both of which the LWV supported.
- Support:

HB 290 (no excuse absentee voting)

Oppose:

SB 180 (would allow businesses to refuse to provide services on religious grounds)

One hundred fifty-one individuals became new citizens, 55 registered immediately to vote and many more sought voting information.

The next morning League members, ready with numerous questions about proposed legislation, were treated to a lively discussion with Representative Susan Westrom (D) at the Democracy Brunch. (Republican legislators were invited to participate but none were able to.)

Rep. Westrom addressed budget concerns as well as the status of several bills of interest to the League, including educational standards, campaign finance changes and restoration of felons' voting rights. She provided a fascinating explanation of legislation (HB 438) she is co-sponsoring that provides for full transparency in the use of federal funds by Area Development Districts, which has been quite a contentious issue. Members quickly discovered they had a lot to learn about these agencies, how they operate and various challenges some of them present regarding oversight and accountability.

Rep. Westrom has our thanks for taking time from her demanding schedule to meet with us.
