

#### LWV Impact on Issues 2012-2014

*Impact on the Issues 2012-2014*, the official LWV guide to its public policy positions, is available at the national website <u>lwv.org</u>. This document is an invaluable resource to local Leagues as they work at state and local levels. It includes the two positions adopted in 2014—<u>Federal Agriculture Policies</u> and <u>Human Trafficking</u>.

The document can be read online, downloaded as a PDF copy, or purchased in print form (\$4 per copy).

## One Last Task in 2014

Before we begin our busy holidays there is just one more very simple task we can do that could have important political impact. Just one simple step...

We must tell the FEC (Federal Election Commission) what they can do about *Citizens United*. Super PACS raised and spent more than **\$600 million** in 2014 to elect candidates who would do their bidding.

The Federal Election Commission can do something to stop the secret money and end the coordination between Super PACs and candidates, which would put a lid on much of the outside spending from special interests. We must tell the FEC to stop the coordinated spending that is poisoning our elections!

The FEC has authority under existing law, even after *Citizens United*, to set disclosure rules and rigorously define "coordination," but, thus far, they have refused to do so. **The FEC is now receiving pub**lic comment about steps they should take "to address corruption in the political process." As League supporters, we know how important specific regulations can be. <u>We need to tell the</u> <u>FEC to act and enforce the law</u>. It is as simple as that.

On the national LWV website there is posted a user-friendly email that can be sent to the FEC. You can use the language provided or tailor it to suit your own personal message.


