## The Last Naturalization Ceremony of 2017



The last naturalization ceremony of the year was held on November 17, 2017 at the Federal Courthouse with Judge Gregory F. Van Tatenhove presiding. **Nancy Chesser** spoke for the League and members **Jennifer Jackson, Mary Hughes, and Cecile Schubert** joined her in assisting 11 new citizens to register to vote by paper and four others to register electronically. Instructions for online registration and paper registration forms were given to several more new citizens who wanted to register at a later time.



Having the Surface Pros provided by the Secretary of State’s office available for new citizens to use ensures that their registrations are submitted immediately with no potential for loss or tampering. The online system is easy—a registrant simply opens a browser window and types in [govoteky.com](http://govoteky.com). No special training is necessary for League members who volunteer to help with future registrations. Anyone can be shown on site how to operate the laptops.

We are grateful to Nancy Chesser who has facilitated voter registration at naturalization ceremonies for three years. She now passes that responsibility to Jennifer Jackson who says her goal for 2018 is to increase our new citizen voter registration by 50%. ## Please Review the KDE Bible Literacy Standards

The LWV of KY Education Committee asks that you respond to a request for comment by the KY Department of Education (KDE) concerning the proposed Bible literacy education standards. The passage of a state law in 2017 called for the Education Department to create academic standards for the following elective social studies classes: Hebrew Scriptures and the Old Testament of the Bible, the New Testament of the Bible, and Hebrew Scriptures and the New Testament of the Bible. Each of the three proposed courses will focus on the historical impact and literacy style of the identified texts and teach biblical content, figures, poetry and narratives that the department says "are prerequisites to understanding contemporary society and culture, including literature, art, music, mores, oratory and public policy." The courses are to maintain religious neutrality and accommodate diverse religious view, traditions and perspective. School-based decision making councils may offer the courses to students in grade nine and above.

Please note that these courses have been designated as social studies courses, but they might best be taught as part of a literature course. In addition, there do not appear to be any assurances (only suggestions) that other religious books be used.

## National LWV Call to Action

The LWVUS is calling on members to take three specific actions. On the website [www.lwv.org](http://www.lwv.org), click on the link **TAKE ACTION**. At the top of the next page are three links.

1. **URGE CONGRESS TO SUPPORT THE AUTOMATIC VOTER REGISTRATION ACT.** Senator Patrick Leahy (D-VT) and Representative Robert Brady (D-PA) introduced the Automatic Voter Registration Act of 2017 on June 14, 2017. The League is proud to support legislation that enhances access for eligible voters in our elections and works to modernize our electoral system. This bill will improve the accuracy of voter records, cut down on costs, modernize outdated registration systems while supporting implementation in states across the country. **PROVIDE THE IDENTIFICATION REQUESTED AND CLICK ON SUBMIT.**
2. **TAKE ACTION TO SAVE HEALTH CARE.** There are clear instructions for placing a call to the Capitol Switchboard and the message to deliver when connected. **CALL THE NUMBER PROVIDED.**
3. **STOP VOTER SUPPRESSION—SIGN THE PETITION.** The so-called “Election Integrity” Commission, chaired by Vice President Mike Pence and Kansas Secretary of State Kris Kobach, is seeking to find potential fraudulent registration on voter rolls across the country. They’ve requested personal, confidential information from all fifty states that threatens the privacy of Americans...This Commission is not interested in facts, but rather false accusations in order to implement dangerous election policy. **COMPLETE THE INFORMATION TO SIGN THE PETITION.**
